

# FUJIFILM NZ Mothers' Day 2025 Prize Draw Promotion Terms and Conditions

## What is this promotion?

1. This prize draw promotion ("**Promotion**") offers FUJIFILM NZ Limited ("**FUJIFILM NZ**") customers ("**FUJIFILM Customers**") who purchase one Qualifying Product (described further below) one entry in the draw to win the prize described in paragraph 17 ("**Prize**").

## How long does the promotion run for?

2. The Promotion commences at 00:01 on Monday 21<sup>st</sup> April 2025 and continues until 23:59 on Sunday 11<sup>th</sup> May 2025 ("**Promotional Period**"). For the avoidance of doubt, this Promotion does not apply to purchases of Qualifying Products made after 23:59 on Sunday 11<sup>th</sup> May 2025 or to entry forms received by FUJIFILM NZ after that date and time.

## How do I participate?

3. To participate in the Promotion, you must:
  - 3.1. purchase a product set out in paragraph 13 below from an authorised FUJIFILM NZ retail partner (a list of which is available at <https://www.nz.fujifilm.co.nz/photo-printing-store-locator/> ) ("**Retail Partner**") ("**Qualifying Product**") during the Promotional Period, while stocks last, and keep evidence of your purchase;
  - 3.2. submit a properly and fully completed entry form at <https://www.nz.fujifilm.co.nz/promotions>. The entry form will require the following key details:
    - 3.2.1 your full name and contact details;
    - 3.2.2 your preferred delivery address;
    - 3.2.3 the date of the purchase of your Qualifying Product;
    - 3.2.4 the name of the Retail Partner that you purchased your Qualifying Product from; and
    - 3.2.5 proof of the purchase of the Qualifying Product, such as a scan or photo of the original receipt issued for the Qualifying Product, or such other proof of the Qualifying Product as is acceptable to FUJIFILM NZ in its sole discretion.
4. Only one entry form may be completed per Qualifying Product purchased.
5. All entry forms must be validly lodged and received by FUJIFILM NZ no later than 23:59 on Thursday 22<sup>nd</sup> May 2025. FUJIFILM NZ will not process any entry forms received after this date and is not responsible for late, lost, incomplete, incorrect or misdirected entry forms that have previously been submitted to FUJIFILM NZ.
6. This Promotion is not available in conjunction with any other promotions or offers whatsoever.

## How will I know if I have won a Prize?

7. Each validly submitted entry form received by FUJIFILM NZ during the Promotional Period will receive 1 entry into the draw to win a Prize.
8. The Prize draw will take place at FUJIFILM NZ's offices on Monday 26<sup>th</sup> May 2025. The winner will be drawn randomly from all valid entries received during the Promotional Period.
9. If a successfully-drawn entry form is later rejected in accordance with these Terms and Conditions, then FUJIFILM NZ reserves the right to make subsequent further draw(s) until the Prize is won by a participant who has followed the Terms and Conditions of this Promotion.

10. FUJIFILM NZ will notify the winner using one of the contact details provided in the entry form and request that such winner provides to FUJIFILM NZ the necessary information to validate that winner's entry and enable delivery of the Prize (including providing details of a postal address and age). If we do not receive all required information within 5 business days of us notifying you of your win, we may reject your successfully-drawn entry and carry out a subsequent Prize draw.

11. The successfully verified winner will:

11.1. A two night stay at **Acacia Cliffs Lodge** ([Acacia Cliffs Lodge - Guest Reservations](#)) and one spa treatment at **Taupo DeBretts Spa Resort** ([Body Treatments & Spa Packages | Taupo DeBretts Spa Resort](#))

and will be provided with details about how to redeem that part of the Prize within the Redemption Period (see paragraph 20).

12. FUJIFILM NZ will publish the name of the winner at <https://www.nz.fujifilm.co.nz/promotions> on 26th May 2025.

### What are the Qualifying Products?

13. To participate in the Promotion, you must purchase a printed photo product within the Promotional Period from one of the retailers listed at <https://www.nz.fujifilm.co.nz/photo-printing-store-locator/>. The Promotion does not apply to any other products.

14. Each Qualifying Product that is purchased during the Promotional Period will entitle a participant to submit 1 entry into the Prize draw. For example, if two Qualifying Products are purchased then you are entitled to submit 2 entries into the Prize draw. The minimum transaction value must be \$10 to qualify.

15. Qualifying Products must be paid for in full in a single transaction.

### Who is running this promotion?

16. FUJIFILM NZ Limited of 2C William Pickering Drive, Rosedale, Auckland 0632 is the promoter of this Promotion.

### What is the Prize?

17. The total Prize value of this Promotion is \$1515NZD consisting of 1 Prize comprising the items set out below:

Value	Item
\$1200 NZD (approx.)	2 x person one night stay at Acacia Cliffs Lodge
\$315 NZD (approx.)	1 x Spa Treatment for Two People at Taupo DeBretts Spa Resort

18. The "Relaxation Prize" includes:

18.1. A two night stay at **Acacia Cliffs Lodge**.

18.2. Return economy airfares for 1 adult and 1 additional adult or child aged 14 or over.

18.3. 2 days' car rental. The Prize winner or other travelling adult must be 25 years or older and hold a valid unrestricted driving licence to be eligible for this component of the Prize. If neither the Prize winner nor the other travelling adult meets this criteria, the Prize winner will be issued a Prezy Card to the value of the 2 day car rental (as determined by the Promotor in its sole discretion) to cover the costs of ground transportation.

18.4. One spa treatment at Taupo DeBretts Spa Resort for two people.

19. Other than as set out above, the Prize does not include transfers to or from any airport, ride shares or taxi fares, meals, drinks, activities, additional accommodation or spending money, the cost of obtaining travel

insurance, upgrades or changes to flights or accommodation and all other incidental costs associated with redeeming the Prize.

20. The Relaxation Prize must be redeemed between May 2025 and December 2026 (“**Redemption Period**”). No compensation will be paid by FUJIFILM NZ if the winner is unable to redeem that part of the Prize during the Redemption Period.
21. Any accommodation, flights and car rental components of the Prize must be used during the Redemption Period.
22. Economy seats with Air New Zealand are subject to availability at time of booking. FUJIFILM NZ does not guarantee that seats will be available on your requested flight(s).
23. To accept the Prize, you may be required to accept terms and conditions from providers of Prize products or services (“**Third Party Terms**”). If you refuse to accept any such Third Party Terms, you forfeit your right to receive the Prize.

#### **What personal information of mine may be collected and on what terms?**

24. As a condition of entering this Promotion:
  - 24.1. you consent to FUJIFILM NZ publishing your name (if you are a Prize winner) on the FUJIFILM NZ website <https://www.nz.fujifilm.co.nz/promotions>;
  - 24.2. you consent to FUJIFILM NZ using your personal information to administer the Promotion, including disclosing the FUJIFILM Customer’s personal information to organisations that assist FUJIFILM NZ with administering this Promotion; and
  - 24.3. you consent to FUJIFILM NZ using your personal information for future marketing purposes, unless otherwise advised by the FUJIFILM Customer. You may access and correct any personal information held by FUJIFILM NZ, upon request to FUJIFILM NZ.
25. FUJIFILM NZ respects the privacy of its customers. Any personal information collected in relation to this Promotion will be collected, held, used and disclosed in accordance with its privacy policy, which is available at <https://www.fujifilm.com/nz/en/privacy>.

#### **What other things should I know about the Promotion?**

26. FUJIFILM Customers who participate in this Promotion are deemed to have agreed to be bound by these Terms and Conditions.
27. The Promotion is only open to FUJIFILM Customers who purchased the Qualifying Product in New Zealand, are residents of New Zealand (and so have a postal address in New Zealand) and who are at least 18 years old.
28. FUJIFILM NZ reserves the right to accept or reject any entry form that is incorrect, incomplete or otherwise does not meet the requirements of these Terms and Conditions.
29. If FUJIFILM NZ discovers any fraudulent conduct in respect of any entry, FUJIFILM NZ reserves its rights to reject any entry form and pursue any legal action available to it.
30. Any tax liability, which may arise as a result of winning any Prize, will be the sole responsibility of the relevant Prize winner.
31. FUJIFILM NZ excludes all liability for any loss, damage or injury of any nature howsoever caused or sustained by any participant under this Promotion (except in the case of a participant that is a winner under the Prize draw and who has fully complied with these Terms and Conditions where liability is instead limited to \$500).

32. FUJIFILM NZ is not liable for any failure to fulfil the Promotion or to satisfy any of these Terms and Conditions or for any terms which may be imposed on a Prize winner by a third party organisation in connection with the Prize, owing to circumstances beyond its reasonable control.
33. To the extent permitted by law, FUJIFILM reserves the exclusive right to amend these Terms and Conditions as may be reasonably required to address any issue that arises during the Promotional Period that impacts the efficient running and operation of the Promotion.
